LPA focus on Federal election lead-up and 2016 Helpmann Awards

The last month has seen LPA staff focus a lot of time and resource on getting our message out regarding LPA's election priorities. Members will have seen a number of media releases, particularly our analysis of the impact of the Australia Council's recent four year funding announcement. We have also provided a tool kit for Members to use in the next few weeks as part of your lobbying activities.

Our attention has now moved to the local level where we are targeting a range of marginal and key seats nationally. We have contacted candidates from all major parties raising our concerns and encourage Members to do the same, as you deem appropriate for your company. It is important to raise our voice during this campaign and let our politicians know that we are a \$2.5 billion industry that employs 35 000 plus people across the country. We are calling on all major parties to commit to restoring \$72.8m to the Australia Council and to outline their plans for jobs and growth for the live performance industry.

We will shortly release a mid-election report card on where the major parties stand on support for our industry, including if they have an arts policy, a plan for jobs and growth plus an assessment of proposed initiatives against our list of priorities. Next week on Wednesday 8 June there is a national arts debate in Melbourne with Minister for the Arts Mitch Fifield, Shadow Minister for the Arts Mark Dreyfus and Adam Bandt, Arts spokesperson for the Greens, all participating. The debate will be mediated by Patricia Karvelas (ABC and Sky News) and live streamed 1-3pm. We will send tune in details shortly.

At the same time as we are lobbying on behalf of our Members, we are also preparing for the 2016 Helpmann Awards which are fast approaching. Over the next two weeks our eight Helpmann Award

REPORT FROM INQUIRY INTO LIVE PRODUCTION TO RURAL AND REGIONAL AUSTRALIA

The House of Representatives Standing Committee on Communications and the Arts has released a report entitled "Arts and the news to rural and regional Australia" following its Inquiry into broadcasting, online content and live production to rural and regional Australia.

The report includes several recommendations for improving access to the arts as follows:

- continuing funding for Australia's major performing arts companies
- recognising the dynamic and changing nature of the arts in grants programs
- encouraging the educative role of performing arts companies
- maintaining adequate funding for the Australia Council for the Arts'
 Playing Australia program
- retaining National Touring Status arrangements and extending them to additional performing arts companies
- encouraging and formalising mentoring arrangements between performing arts companies and rural and regional communities
- evaluating and promoting the new Catalyst Australian Arts and Culture Fund
- considering funding and support for digital innovation in the delivery of the arts, and
- opening up the eligibility for the Catalyst fund to include funding for competitions and eisteddfods.

LPA will update Members with the Federal Government's response to this report when it becomes available.
