

#### Federal and State Budget Updates 2018-19

This past month the 2018-19 Federal Budget, as well as the Victorian (VIC), Western Australian (WA), and Northern Territory (NT) State Budgets were released.

- The **NT Budget 2018-19** (released 1 May 2018) included no new funding initiatives for live performance. (Budget Papers available <u>here</u>)

• The **WA 2018-19 Budget** (released 10 May 2018) allocated \$6.5 million to refurbishment of His Majesty's Theatre. Works will include installation of an orchestra pit lift and safety improvements at the venue. The WA Budget 2018-19 also stated that a projected decline in Lotterywest revenue will impact the funding available to arts and cultural organisations and sporting groups. The Budget Papers indicate that the relevant Department is working closely with Lotterywest and its stakeholders to minimise the impact of the changes in funding.
