#### Dear Member,

It's been a busy month with the release of <u>LPA's annual Ticket</u> <u>Attendance and Revenue Survey</u> (2016 data). The industry posted \$1.43 billion revenue and 18.78 million attendances. While revenue and attendance growth was modest, the figures indicate the industry is stable which is good news after seeing declines in the previous two years. Overall since 2008, industry revenue has increased by 35% and attendance has grown by 19%. These figures underscore the economic and cultural value of the live performance industry for millions of Australians. They also support our argument for increased investment and the need for a more strategic approach from federal government. <u>Click here to view our media release</u>.

Members would also be aware that the NSW Government introduced ticket scalping legislation. Following the introduction of the Fair Trading Amendment (Ticket Scalping and Gift Cards) Bill 2017, LPA hopes that the federal government will respond to our call for legislation to criminalise 'bots' consistent with recent legislation in the UK and US. Bots are a problem for all e-commerce businesses not just our industry. This is a global problem and Australia should be part of the global response. While we acknowledge the NSW Government's legislation to prohibit the use of software to bypass security measures in order to purchase tickets, we are concerned that state based legislation, unless it is uniform nationally, will be ineffective. LPA will continue to advocate in this area.

The election for the Executive Council is underway. It's great to see so many members standing for election this time round. Members will receive ballot papers from the Australian Electoral Commission with voting instructions. The newly appointed Executive Council will be announced at the Annual General Meeting on 1 December.
