Dear Member,

This month has seen us continue to focus on ensuring consumers are better educated about the risks of buying tickets from the secondary market. We released our <u>Safe Tix Guide</u> and encourage all members to get this guide out to your audiences, fans and relevant interest groups.

CELEBRATING

A century of serving our members

Members would be aware that the ACCC announced this week it has instigated court proceedings against Viagogo alleging it made false or misleading statements, and engaged in misleading or deceptive conduct, regarding the price of tickets on its online platform by failing to disclose substantial fees. Three state based consumer affairs agencies (Qld, NSW and WA) also issued public warnings with respect to Viagogo.

LPA continues to lobby government for legislation to criminalise ticket bots. We are also completing revisions to our Ticketing Code to incorporate provisions applying to the secondary market. Prior to publicly releasing this revised Code, we will be consulting with the ACCC, and are aiming to get it out as soon as possible after we have their input.

We are nearing completion of our negotiation with APRA regarding a revised definition and tariff for the Dramatic Context Licence. We expect to be advising members of the final details next month. The Department of Communications and the Arts is also undertaking a review of the Code of Conduct for Copyright Collecting Societies as part of the Government's response to the Productivity Commission's inquiry into Australia's intellectual property arrangements. LPA has been invited to be part of the review committee and will also be preparing a submission, due mid-September.

Last week, we were pleased to release our <u>public statement</u> <u>supporting a yes vote for marriage equality</u> jointly with MEAA and SPA. We encourage our members to consider this important issue and where they can support the industry position. The Palais Theatre is a live performance venue based in St Kilda, Melbourne. As of April 2017 Live Nation Australia Venues has taken on the Palais Theatre's operations and restoration works which will see it transformed over a 30 year period.

The Bureau of Communications and Arts Research (BCAR) in the Department of Communications and the Arts has announced that it will be undertaking this review and is inviting submissions.

LPA will be providing a submission to this review, as well as representing our Members' interests on the External Reference Group (ERG) established by the BCAR to support the Code review.
