We're in Helpmann Award season and consequently a lot of time in the past month has been devoted to the upcoming event at the Capitol Theatre in Sydney on Monday 24 July. The nominees were announced nationally on Monday 19 June in Sydney, Melbourne, Brisbane, Adelaide and Perth. A big thankyou to STC, Arts Centre Melbourne, QPAC, Adelaide Festival Centre and State Theatre Centre, WA for hosting these events. We very much appreciate the support and hard work of all the teams in each city.

Tickets are on sale now so if you haven't got yourself organised yet, **buy today so you don't miss out!** It's going to be a wonderful night with fabulous entertainment and a stellar lineup of hosts, nominees and industry personalities (more details below).

This morning we also released our call for **Expressions of Interest for the Producer, Helpmann Awards 2018-2020.** Our longstanding Executive Producer, Jon Nicholls, is retiring from the role after our 2017 show so we're inviting submissions from suitably qualified person(s), groups or organisations to produce the annual Helpmann Awards 2018-2020.

Members would also be aware of the recently announced changes
to the 457 visa. LPA made a submission to the Department of Immigration and Border Protection (DIBP) recommending that a range of occupational categories be added to the MLTSSL(mediumlong term) list to provide certainty of a four year visa term and the potential pathway to permanent residency. LPA submitted the following categories for inclusion: Artistic Director, Musical Director, Musician (Instrumental), Dancer/Choreographer, Arts Administrator or Manager (senior level), and CEO. On Friday the DIBP announced some changes. Some of our recommendations were adopted, with the Chief Executive and Musician (Instrumental) occupations being moved to the four-year MLTSSL list. Others remain on the STSOL, such as Arts Administrator or Manager and Dancer/Choreographer. Additionally, some occupations previously removed from the 457

company for Beautiful: the Carole King Musical.

Bizarro

Bizarro is an independent booking, touring, management and creative agency. Bizarro operates tours of local and international acts, mainly within house, techno, disco style music.

Cultural Infusion

Cultural Infusion delivers programs to schools to build intercultural understanding to communities and youth. Presenters from diverse cultural backgrounds are used to deliver these programs (which may involve bringing presenters from overseas).

PlayWriting Australia

PlayWriting Australia supports playwrights with investment to develop new work and professional development. The organisation supports theatre companies and producers to find and commission playwrights, supports the creative development of a new play project, as well as assist in selecting the right dramaturg to better develop a new project.

The Prestige Presents

Neil Croker (under the banner of The Prestige Presents) will develop theatre and provide advisory services. Neil was formerly CEO of the Palais Theatre, a position he held for 10 years. He also has experience directing and producing events (e.g. AC/DC, Dire Straits, Carole King, Bette Midler, Michael Jackson, John Farnham, Tom Jones and Riverdance) and consulting to a wide range of

occupations list have been moved to the STSOL list (eg. Artistic Director, Dressmaker/Tailor and Music Director), enabling a possible two year visa to be extended for an additional two years.

In its submission, LPA also recommended that Dancers should be exempt from the work experience requirements for attaining a 457 visa and that the training levy should be waived for not-for-profit and government subsidised organisations. We expect to talk further with the relevant government departments about these matters and will keep members posted.

The policy team is now finalising the draft Code of Practice for Ticketing with new clauses covering the secondary ticket market. We expect to consult with the ACCC in July prior to it going to the Executive Council for approval.

The Fair Work Commission's annual wage review has resulted in an increase of 3.3% to the minimum wage and a CPI increase to certain expense-based allowances.

The increases will be applied to minimum wages across all Modern Awards by the FWC in the coming weeks, to take effect from the first full pay period on or after 1 July 2017.

This wage increase will apply to the minimum award rates of pay only. There is no obligation to pass on this increase to employees who are remunerated in excess of the award minimums, through higher hourly rates or a salary, for example. organisations in the entertainment industry.

Employees who are paid in accordance with an enterprise agreement (such as the Performers' Collective Agreement) do not receive a wage increase unless:

- 1. The agreement states that the national wage increase is to apply to agreement rates; or
- 2. The national wage increase would make the base award rate of pay higher than that prescribed by the agreement, in which case the higher award rate applies.

Enterprise agreements may also specify that expense-related allowances increase in line with the award. For example, employers to whom the Performers' Collective Agreement 2017 ("PCA") applies should be aware of the **increased travel allowances in Table E**, **Schedule 1.**

Please note that wages under the PCA have not increased, and will not do so until a new agreement is negotiated with the MEAA.

LPA SUBMISSION TO THE VET STUDENT LOANS COURSE LIST AND LOAN CAPS METHODOLOGY REVIEW

LPA provided a submission (dated 30 May 2017) to the VET Student Loans Course List and Loan Caps Methodology Review undertaken by the Department of Education and Training.

In our submission LPA provided feedback on the Government's current methodology for determining eligible courses and associated loan caps for VET Student Loans. LPA advised that the VET Student Loans program needs to ensure that the eligible course list encompasses the range of quality VET courses that are valued by the live performance industry and delivered by reputable institutions.



CONNECTING AUSTRALIANS: RESULTS OF THE NATIONAL ARTS PARTICIPATION SURVEY

The National Arts Participation Survey is the third in a series delivered by the Australia Council, following previous editions in 2009 and 2013. It measures Australians' engagement with, and attitudes to, the arts. It confirms the significant and increasing personal value Australians place on the impact of the arts, and the ways in which they make our communities stronger and more cohesive.

MTC LAUNCH NEXT STAGE WRITERS' PROGRAM

Melbourne Theatre Company recently launched the NEXT STAGE Writers' Program; a commissioning and development initiative created to support Australian Playwrights.

The five year program involves a \$4.6 million investment, \$2.3 million from the visionary donors of MTC's Playwrights Giving Circle, complementing \$2.3 million contributed by MTC, and will:

- provide a total of 50 residencies and commissions
- commission a minimum of 35 new plays, with flexibility in commission fees to allow writers additional time and resources to write:
- engage up to 15 playwrights as writers-in-residence for up to three years; and
- increase resources to workshopping and developing plays going through to production to ensure that they have been afforded every level of creative scrutiny and artistic support in making the finest possible work.

Across five years, MTC will have writer-in-residence opportunities for up to 15 writers who have a background in playwriting and would benefit from specific experience of, and writing for, a major company's mainstage.

Residencies will be available by application only. Applications for the three 2017 Residencies are now open at mtc.com.au/careers
