Thank you to all LPA Members that provided feedback to LPA's submission for the Review to the efficacy of the Code of Conduct for Australian Copyright Collecting Societies. LPA's submission highlighted Member's concerns with respect to APRA (and to a lesser extent PPCA), such as:

- Lack of timely response to licensing requests or queries, causing uncertainty as to whether music can be used and placing undue stress on licensees and artists
- Inconsistency in the interpretation of licence classification. Shows that have historically been licensed under one category being reclassified to a different (higher tariff) category, even though there have been no changes to the licensing framework

Performing Lines

Fenn Gordon stepped down from her role as Senior Producer of Performing Lines at the end of September. She will continue to work with Performing Lines on certain projects as an independent contractor.

Step 2: Log in to your ImmiAccount and enter each applicant's personal information

Input the data for all applicants via the online form. <u>LPA has</u> prepared a short Immi Account guide to explain this process.

Step 3: Send the following to LPA:

- A 956a form, signed by each applicant
- A signed letter of invitation
- A completed NEB Statement
- Any relevant contracts
- A clear scan of each applicant's passport photo page
- Travel/health insurance documents.
- Credit card details for the visa application charge, if applicable.

LPA will then check and lodge the application on your behalf.
