Dear Member

April has been a very busy month as we ramp up for the 18th annual Helpmann Awards in Sydney. Entries closed on Friday and we will be making some announcements later in the week so watch this space.

LPA also hosted a very successful Roundtable last week with 25 representatives from Government and other service based associations to scope education and training resources for preventing workplace discrimination, harassment, sexual harassment and bullying. The following areas were identified as priorities: online training tool for all employees; training for boards, CEOs and senior managers; contact and complaints person training; industry employee assistance program; compliance, data and evaluation; list of tools and resources that can be accessed; engaging training institutions with skilling the future workforce in this area; greater awareness of respectful and safe work place boundaries and expectations; and intimacy training/guidelines for rehearsal work spaces.

Following this discussion, LPA is now preparing a training and education program for review by the Executive Council. Work is already well underway to revise the Draft Code following feedback from members. A big thankyou to all those members who gave us valuable comments. We expect to complete the Code and release it mid-year.

May will keep us very busy with Helpmann Awards panel meetings as we get ready to announce all the nominees on Monday 18 June. Stand by for further details.

New online application for employers of children in NSW

The Office of the Children's Guardian is making it easier for employers of children to apply for an authority. You can now apply for this authority **online**. The newly automated form now takes only 4 minutes to complete. A secure online payment system provides instant proof of payment when using your credit card, and you can still take care of fees by electronic funds transfer.

Organisations employing children under 15 years for a live performance in NSW are required by law to get an authority.

The Office of the Children's Guardian does investigate allegations of unauthorised employment in the industry. Employers have been issued with fines of \$5,500 per child where it has been found that unauthorised employment has taken place.

Tips before you apply online:

- Have your company's correct ABN handy
- Select the right type of authority and duration. An entertainment and exhibition authority covers all types of work.
- Your authority start date and duration should cover each day that a child is employed, including preparatory activities such as wardrobe checks and rehearsals
