A Message from the CEO

The last month has seen us focused on resolving issues with regard to the Department of Immigration and Border Protection's (DIBP) new 408 Temporary Visa. As previously advised, DIBP has refused to reconsider a 'bulk discount' for large international touring parties. However, the Minister did agree to implement some transitional arrangements for the period 19 November 2016 to end June 2017. Details of these arrangements can be found below. The DIBP has also confirmed the parameters for visa fee concessions. LPA has some concerns about the extent to which the DIBP has narrowed the range of companies that can receive the fee concession and we are currently consulting with Members to measure the impact of the new framework.

LPA also met recently with the Australasian Performing Right Association (APRA) regarding its proposed change to the definition of the Dramatic Context Licence. LPA has raised a number of concerns with respect to the proposed new definition and expects to meet with APRA again in early 2017 to resolve these matters.

Our annual Ticket Attendance and Revenue Survey will be released publicly on 1 December and all Members will receive our Media Release and link to the e-report on Thursday 1 December.

Members would be aware that LPA's AGM and Industry Briefing will be held this week in Melbourne. Background information, including our **Annual Report**, has been sent to all Members. We look forward to meeting many of you at that event. If you are unable to come, please get us your proxy.

The new 408 visa brings with it a raft of changes. Despite strong opposition, the Federal Government has proceeded with the removal of the bulk discount for applications of 20 or more personnel. LPA has obtained a concession whereby affected parties will be subject to transitional arrangements for a limited time, reducing the fee from \$275 to \$70 per head. In addition, the criteria for fee exempt status have been further restricted. Members who have previously been exempt from visa fees should ensure they are still eligible.
