

Significant changes to Federal Whistleblower Laws commencing 1 July 2019

The Federal Government has made changes to Australia's existing Whistleblower protection regime. The laws will commence on 1 July 2019 and will apply to public companies and large proprietary companies.

There will be several significant changes summarised here.

Artistic Director David McAllister AM announced he will retire from **The Australian Ballet** in 2020, his 20th year in the role.

**Circus Oz** Artistic Director and co-CEO Rob Tannion will leave the company on Friday 28 June 2019 as he accepts a new opportunity with **Cirque du Soleil.** 


#### Bangarra Dance
