RULES APPLYING TO THE MEETING

Voting and Polls - Rule 33

"At all meetings of the Association the voting will be by show of hands unless a poll is required as provided by this Rule 33. On a show of hands each Financial Member present, either in person or by proxy will have one vote. On a poll each Financial Member will have one vote for each \$100 paid by the Financial Member by way of membership fees and contributions for the 12 month period ending 30 June. Any fraction of \$100 in such membership fees and contributions will be disregarded. Those Life and Honorary Members who have an entitlement to vote under Rule 8(b) will have a minimum of one vote notwithstanding anything in this Rule."
