<p><u>How many people can attend?</u></p> <p><u>INDOOR & OUTDOOR</u></p> <p>One person per 4 square metres (excluding staff), OR 50% capacity of the venue (to a maximum of 1000 persons including children), whichever is the greater.</p> <p>Calculating space available using the 4sqm rule:</p> <ul style="list-style-type: none"> • Not more than 200 square metres of floor space: Consider the entire premises • More than 200 square metres of floor space: only consider areas that are open to the public <p>When calculating the space available for each person, do not include: —</p> <ul style="list-style-type: none"> • Any person engaged in work on the premises for the occupier of the premises • If the premises are for food and drink, any person ordering or collecting food or drink to takeaway. 	<p><u>How many people can attend?</u></p> <p><u>OUTDOOR ONLY (REGIONAL VICTORIA)</u></p> <p>Outdoor spaces with no seating, where people can freely move around (excludes events) in Regional Victoria:</p> <ul style="list-style-type: none"> • One patron per 4 square metres, rounded down to the nearest full number <p>Outdoor spaces with seating in Regional Victoria:</p> <ul style="list-style-type: none"> • Fixed seating: the lower of 50 people or 25% of the venue’s fixed seat capacity • No Fixed Seating with allocated seated spaces: one person per 4 square metres, with a maximum of 50 patrons • Groups are limited to 10 people and must be seated 1.5 metres from other groups. 	<p><u>How many people can attend?</u></p> <p><u>INDOOR</u></p> <p>Venues of 200 square metres or less:</p> <ul style="list-style-type: none"> • One person per 2 square metres (up to a total of 50 people) for <p>Venues of 200 square metres or more:</p> <ul style="list-style-type: none"> • One person per 4 square metres. <p><u>OUTDOOR</u></p> <p>One person per 2 square metres and up to 75% of seated venue capacity.</p>	<p><u>How many people can attend?</u></p> <p><u>INDOOR</u></p> <p>One person per 2 square metres. Including staff at venues that hold more than 500 patrons.</p> <p><u>Major sport and Entertainment venues:</u></p> <p>50 per cent capacity.</p> <p>The temporary capacity of major stadiums is:</p> <ul style="list-style-type: none"> • Optus Stadium (Concerts – 35,000) • HBF Park (Concerts – 16,500) • HBF Stadium (Concerts – 2945) • RAC Arena (Concerts – 8250) 	<p><u>How many people can attend?</u></p> <p><u>INDOOR</u></p> <p>One person per 2 square metres, at a place:</p> <ul style="list-style-type: none"> • (as a whole), or • the total number of present in any single room or enclosed area. <p>These requirements apply only to patrons, not staff.</p> <p>The maximum number of attendees at a place of business is determined by its size.</p>	<p><u>How many people can attend?</u></p> <p><u>INDOOR</u></p> <p>Whichever is lower:</p> <ul style="list-style-type: none"> • One person per 2 square metres: or • 250 people per single undivided space. <p><u>OUTDOOR</u></p> <p>Whichever is lower:</p> <ul style="list-style-type: none"> • One person per 2 square metres: or • 1,000 people for outdoor each single undivided space. <p>All people in any single undivided space count towards the maximum number of people permitted. Children and babies also count towards the maximum number.</p>	<p><u>How many people can attend?</u></p> <p><u>INDOOR and OUTDOOR</u></p> <p>Whichever is lower:</p> <ul style="list-style-type: none"> • One person per 4 square metres of usable space, • 100 people in each indoor space and each outdoor space (excluding staff) <p>Usable space is the space that people can freely move around in, not including the following areas:</p> <ul style="list-style-type: none"> • stages & similar areas; • restrooms, changerooms & similar areas; • areas occupied by fixtures, fittings, and displays; and • staff only areas and areas that are closed off or not being used. <p>Audiences must remain seated, with 1.5 metres between seated groups within cinemas, movie theatres and live performance venues.</p>	<p><u>How many people can attend?</u></p> <p><u>INDOOR and OUTDOOR</u></p> <p>Patrons can attend any cinema or theatre, concert hall, music hall, dance hall, nightclub, amusement venue, any other similar entertainment venue, as well as any arena, stadium, sporting facility including community and sporting competitions, with spectators seated in accordance with their approved COVID-19 Event Safety Plan.</p> <p>A minimum distance of 1.5 metres should be maintained at all times between individuals who are not family contacts or part of the same household.</p> <p>Physical distancing and hygiene principles should be considered and implemented.</p>

<p>Can Victorians enter NSW with a permit?</p> <p>Victorians can apply for a NSW border entry permit.</p> <p>Anyone who has been in Victoria in the past 14 days cannot enter NSW unless they hold a current entry permit</p> <p>Victorians who do not meet the criteria for a permit to enter NSW can enter, and undertake quarantine, in the Northern Territory. When the quarantine period is complete, the person can then enter NSW without needing to quarantine again.</p> <p>Find out more here.</p>	n/a	<p>Can travellers enter with QLD with a permit?</p> <p>Residents of all states and territories permitted to enter QLD must:</p> <ul style="list-style-type: none"> • Apply for a Queensland Border Declaration Pass • Provide an undertaking that they will present for a COVID-19 test if they develop COVID-19 within 14 days of entering Queensland • Comply with the undertaking while present in Queensland. <p>Find out more here.</p>	<p>Can travellers enter WA with a permit?</p> <p>People who wish to enter WA from another state or territory should apply for an exemption by applying for a G2G PASS.</p>	<p>Can restricted travellers enter SA with a permit?</p> <p>Only approved categories of Essential Travellers from Victoria can enter SA.</p> <p>Find out more here.</p>	<p>Can restricted travellers enter TAS with a permit?</p> <p>All travellers, including Essential Travellers, to Tasmania must register online for a G2G PASS.</p>	<p>Can restricted travellers enter ACT with a permit?</p> <p>Travellers entering the ACT from Victoria must have an exemption from ACT Health.</p> <p>ACT residents must notify ACT Health of their intention to return.</p>	<p>Do travellers need a permit?</p> <p>Anyone entering NT, including returning Territorians must:</p> <ul style="list-style-type: none"> • fill in a Border Entry Form • sign a declaration on arrival <p>Find out more here.</p>

<p>QUARANTINE</p> <p>14-day quarantine in government arranged accommodation for NSW residents returning from Victoria, or Victorians with a valid permit.</p> <p>Who pays for hotel quarantine?</p> <p>The traveller pays:</p> <ul style="list-style-type: none"> • Individual - \$3,000 • Additional adults - \$1,000 • children under 18 - \$500 • child under 3 years - free 	<p>QUARANTINE</p> <p>N/A</p>	<p>QUARANTINE</p> <p>14-day quarantine in a government arranged accommodation for anyone, including Queensland residents, returning to from a hotspot.</p> <p>Exemptions from hotel quarantine can be applied for but are rarely granted.</p> <p>Who pays for hotel quarantine?</p> <p>The traveller pays:</p> <ul style="list-style-type: none"> • Individual - \$2,800 • 2 adults - \$3,710 • 2 adults, 2 children - \$4,620 	<p>QUARANTINE</p> <p>14-day self-quarantine, unless there are exceptional circumstances.</p> <p>Requirements for quarantine will be assessed as part of the G2G exemption application process.</p> <p>Who pays for hotel quarantine?</p> <p>If a traveller is assessed as requiring hotel quarantine, the traveller pays:</p> <ul style="list-style-type: none"> • Individual - \$2,520 • Couple - \$3,360 • Additional person - \$60 per day <p>Find out more here.</p>	<p>QUARANTINE</p> <p>14-day self-quarantine for travellers or returning residents who have been in Victoria in the past 14-days.</p>	<p>QUARANTINE</p> <p>Essential Travellers are not required to quarantine, but must undertake health screening including COVID-19 test on arrival, and comply with the Conditions for Essential Travellers.</p> <p>Non-Essential Travellers</p> <p>Tasmanian residents: 14 days quarantine at their primary residence.</p> <p>Non-Tasmanian residents: 14 days quarantine in government-designated accommodation.</p> <p>Who pays for hotel quarantine?</p> <p>The traveller pays:</p> <ul style="list-style-type: none"> • Individual - \$2,800 • Couple - \$3,800 • Family (2 adults, 1 child) - \$4,300 • Family (2 adults, 2 or more children) - \$4,800 <p>Find out more here.</p>	<p>QUARANTINE</p> <p>14-day mandatory self-quarantine at home or in a hotel, for travellers returning from a Victorian area of restriction or concern.</p>	<p>QUARANTINE</p> <p>14-days of mandatory supervised quarantine, for people who have been in an active declared COVID-19 hotspot (some LGAs in New South Wales and all of Victoria) 14 days before arrival.</p> <p>Who pays for hotel quarantine?</p> <p>The traveller pays.</p> <ul style="list-style-type: none"> • Individual - \$2,500 • Family - \$5,000 <p>Additional 10 days (if required)</p> <ul style="list-style-type: none"> • Individual - \$1,750 • Family - \$3,500 <p>Exemptions may apply under strict criteria.</p>
