<u>How many people can attend?</u> Face masks are mandatory in all public settings for people in NSW over the age of 12. Proof of full vaccination is only required at indoor music festivals with over 1,000 people. <u>INDOOR</u> There is no person limit subject to 100% of fixed seated capacity. No person at an indoor music festival must sing or dance on the premises unless they are a performer at the festival or rehearsing to perform at the festival. <u>OUTDOOR</u>	<u>How many people can attend?</u> Face masks are mandatory: <ul style="list-style-type: none">• in all public indoor settings for people aged 8 years and over• at all major events with over 30,000 people (masks can be removed when patrons are seated outdoors). 1 person per 2 square metres in indoor entertainment venues (except for indoor cinemas and theatres where patrons are seated and wearing a face mask). There are no capacity limits or density limits on indoor and outdoor entertainment venues and events where all people attending (staff and patrons) are fully vaccinated. Unvaccinated people are unable to attend these venues and events unless they have proof of a medical exemption.	<u>How many people can attend?</u> <u>INDOOR and OUTDOOR</u> There are no capacity limits for venues and events. Proof of vaccination will be required in order to gain entry.
