<u>How many people can attend?</u>  Face masks are mandatory in all public settings for people in NSW over the age of 12.  No person at a music festival must sing or dance on the premises unless they are a performer at the festival. An <a href="#">exemption</a> has been made to permit dancing and singing at outdoor music festivals and outdoor events at major recreation facilities subject to the occupier of the premises:  • taking reasonably practicable steps to ensure attendees (patrons not workers) remain seated.	<u>How many people can attend?</u>  Face masks are mandatory:  • in all public indoor settings for people aged 8 years and over  • at all major events with over 30,000 people (masks can be removed when patrons are seated outdoors).  1 person per 2 square metres in indoor entertainment venues (except for indoor cinemas, concerts and theatres where patrons are seated and wearing a face mask).  There is a strong recommendation that people visiting entertainment venues who can access Rapid	<u>How many people can attend?</u>  Face masks are mandatory in all public settings for people in Queensland over the age of 12.  There are no capacity limits or density limits on indoor and outdoor entertainment venues and events where all people attending (staff and patrons) are fully vaccinated.  Unvaccinated people are unable to attend these venues and events unless they have proof of a medical exemption.	<u>How many people can attend?</u>  Face masks are mandatory in all public indoor venues in the Perth, Peel, South-West, Wheatbelt and Great Southern regions.  <u>INDOOR and OUTDOOR</u>  There are no capacity limits for venues and events.  Proof of vaccination is required to enter:  • Indoor entertainment venues  • Major stadiums  • Music festivals and large events (above 500 people)  • All hospitality venues  • The entire Crown Perth complex.	<u>How many people can attend?</u>  Face masks are required in shared indoor public places for people in South Australia over the age of 12.  Some venues (Adelaide Festival Centre, Adelaide Entertainment Centre, Adelaide Oval, Adelaide Convention Centre, and Hindmarsh Stadium) are making it a condition of entry that all persons aged 16+, including staff, are fully vaccinated. Proof of vaccination will be required in order to gain entry.
