### **NATIONAL CABINET UPDATE**

On 31 August 2022, the National Cabinet met and [announced](#) changes to Australia's pandemic settings.

National Cabinet agreed that **from Friday 9 September 2022:**

- The **isolation period** for COVID-19 positive cases will **reduce from seven to five days**. However, the seven days isolation will remain for workers in high-risk settings including aged care, disability care, and home care.
- The **mandatory wearing of masks on domestic flights will be removed**.

- The \$750 Pandemic Leave Disaster Payment eligibility will reflect the changed isolation periods.

### **TASMANIA: EXTENSION OF LIVE PERFORMANCE SUPPORT PROGRAM**

On 30 August 2022, the Tasmanian Government [announced](#) an **extension to the Live Performance Support Program** through to end February 2023.

- The program allows the Government to share some of the risk of potential lost ticket sales if performances need to be cancelled or significantly modified due to changes to the *Public Health Act 1997* relating to COVID-19.
- **Applications will close on 31 January 2023**, with activities occurring on or before 28 February 2023 eligible to be considered for in-principle support.
