- **Update: Face Mask Mandates Lifted (VIC, QLD and SA)**

#### UPDATE: FACE MASK MANDATES LIFTED

##### Victoria

On 21 September 2022, the Victorian Government [announced](#) changes to the mask mandate on Victorian public transport.

**From 11.59pm, Thursday 22 September, face masks will no longer be mandatory on public transport including taxis and rideshare services.**

Masks will still be required in sensitive health settings such as hospitals, care facilities, and allied health providers.

##### Queensland

On 20 September 2022, the Queensland Government [announced](#) changes to the mask mandate on Victorian public transport.

**From 12.01am, Wednesday 21 September 2022, face masks are no longer required on public transport, in a taxi, rideshare vehicle or commercial shuttle.**

Masks will still be required in sensitive health settings such as hospitals, care facilities, and allied health providers.

##### South Australia

On 19 September 2022, the South Australian Government [announced](#) changes to the mask mandate on Victorian public transport.

**From 20 September 2022, face masks are no longer required on public transport, in a taxi and rideshare vehicles.**
