### IMMIGRATION UPDATE: New Temporary Visa Application Charge

#### NEW SUBSEQUENT TEMPORARY APPLICATION CHARGE

Applicants applying for a 408 Temporary Activity Visa (subclass 408) (408 Visa) **from within Australia**, who already hold any kind of temporary visa **that was also applied for within Australia** must now also pay the [Subsequent Temporary Application Charge \(STAC\)](#).

##### How much is the STAC?

The STAC is **\$700 per applicant**.

This is in addition to the 408 Visa fee of **\$410** per applicant.

This charge must be paid for each person in the application and is payable in addition to any other visa charges that apply to a visa application at the time of lodgment.

##### WHEN MUST THE STAC BE PAID?

###### Example 1:

The Applicant is currently in Australia holding a 408 Visa. The 408 Visa was applied for while they were in Australia.

The Applicant is still in Australia and has now been offered further work in the live performance industry and requires a new 408 Visa. In order to apply for the second visa the fee will now include:

- \$410 application fee; and
- \$700 STAC.

###### Example 2:

The Applicant is currently in Australia holding a second year 417 working holiday visa; they applied for this visa while they were in Australia.

The Applicant is still in Australia and has now been offered a role as a
