1. My applicant has passport details that are incorrect on their visa grant, what do I do?

<u>STEP 1</u>: Log in to your Immi account and search for the applicant who has the incorrect details. Click view details under their application.

If you have an applicant who has a lost or stolen passport, advise them to make a police report and obtain a copy. Send this copy to Home Affairs as well as filling in this form and selecting "Stolen" or "Lost".

You should receive a confirmation email from Home Affairs once the passport details have been updated. You can also check the person's visa details in VEVO which will be the most up to date information.

2. My performer's DOB is incorrect on their Visa Grant. What do I do?

STEP 1: Complete a 1023 incorrect answer form and get the visa holder to sign the form

STEP 2: Email the completed form to Home Affairs (see contact details below), kindly asking them to amend the visa holders date of birth in their VEVO before the applicant's departure date. Flag the email as URGENT in the subject line for timely assistance.

4. The performer is told they are not allowed to board the plane, what can I do?

Tell the performer to be polite to the airline check-in staff and ask for a manager. If that fails, ask the airport staff member to call Australian Home Affairs/immigration for any visa clarification.

5. How do I contact Home Affairs in emergency situations via email?

By email: entertainment.visas@homeaffairs.gov.au

When writing to Home Affairs make sure you provide:

- the transaction reference number (this usually starts with E and can be found on the IMMI Acknowledgement of Application Received letter or in your online IMMI account)
- The name of the applicant
- Dates of travel

6. How do I check if my applicant has had their visa application approved or any further information requests from Home Affairs?

<u>STEP 1</u>: Log into the Immi account that was used to apply for the application.

<u>STEP 2:</u> Find the application you are waiting for an update on and click view details.
