- 3. Following the close of nominations, all nominations will undergo eligibility checks to determine if they are complete and all rule requirements are met. Where an issue has been identified the Returning Officer will advise the candidate and provide an opportunity to remedy the defect within a specified period.
  - 4. The Returning Officer will notify all candidates of the outcome of the eligibility checks when the nominations accepted report is issued.

#### **Candidate Statements**

Candidates may submit a statement to be included with ballot material. Candidate statements cannot exceed 250 words. Only statements which comply with the Rules and are received by the Returning Officer by 5:00pm (AEST) on 01/10/2025 can be accepted.

## **Voting Period**

The ballot, if required, will open on 15/10/2025 and close at 10:00am (Australian Eastern Daylight Time (AEDT)) on 19/11/2025.

#### **Scrutineers**

The appointment of scrutineers opens on 17/09/2025 and closes at 10:00 am (AEDT) on 19/11/2025. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
