Lodging Nominations

Nominations open on 17/09/2025 and must reach the Returning Officer, Ann Dougan not later than 5:00pm (Australian Eastern Standard Time (AEST)) on 01/10/2025.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

How to lodge nominations: Nominations must be lodged via the following method(s):

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a **PDF** file to lEBnominations@aec.gov.au

PLEASE NOTE:

- 1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
- 2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
- 3. Following the close of nominations, all nominations will undergo eligibility checks to determine if they are complete and all rule requirements are met. Where an issue has been identified the Returning Officer will advise the candidate and provide an opportunity to remedy the defect within a specified period.
- 4. The Returning Officer will notify all candidates of the outcome of the eligibility checks when the nominations accepted report is issued.

Candidate Statements

Candidates may submit a statement to be included with ballot material. Candidate statements should be no longer than 250 words. Only statements which comply with the Rules and are received by the Returning Officer by 5:00pm (AEST) on 01/10/2025 can be accepted.

Voting Period

The ballot, if required, will open on 15/10/2025 and close at 10:00am (Australian Eastern Daylight Time (AEDT)) on 19/11/2025.

Scrutineer Appointment

The appointment of scrutineers opens on 17/09/2025 and closes at 10:00am (AEDT) on 19/11/2025. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
